**NOTICE OF PROPOSED AMENDMENT TO REGULATION
UWF/REG 4.008**

REGULATION TITLE: UWF/REG 4.008 - Tuition and Fees, Fines and Penalties (Fall 2008)

PURPOSE AND EFFECT: The purpose and effect of the regulation is to reflect the amount of tuition, fees, fines and penalties at the University for the Fall 2008 semester.

SUMMARY: Amendments to this regulation include 1) an increase of 6% in the Undergraduate Matriculation Fees as set by the Florida Legislature and Board of Governors; 2) increases in the Financial Aid fees, which are a percentage of the tuition; 3) an increase in the Late Registration fee; 4) the addition of Equipment Fee and Distance Learning Fee categories; 5) an increase to the Health, Athletic and Activity and Service fees which were approved by the BOT at the December 14, 2007 meeting, 6) a decrease in the Third Time Repeat fee; and 7) changes to the language and an overall reformatting of the information to improve clarity.

AUTHORITY: Section 7, Article IX, Florida Constitution; Board of Governors Resolution dated January 7, 2003; Board of Governors Regulation Development Procedure 7/21/05; Section 1009.24, Florida Statutes; and the Florida General Appropriations Act (2008).
