- \_\_\_\_\_ 1. I am 24 years of age or older by the first day of classes of the term for which residency status is sought at a Florida institution  
**(as verified by official UWF academic record)**

**(as verified by marriage certificate)**
- \_\_\_\_\_ 3. I have children who receive more than half of their support from me  
**(as verified by copy of student’s Federal Tax Return)**
- \_\_\_\_\_ 4. I have other dependents that live with and receive more than half of their support from me  
**(as verified by copy of student’s Federal Tax Return)**
- \_\_\_\_\_ 5. I am a veteran of the United States Armed Forces or I am currently serving on active duty in the United States Armed Forces for purposes other than training  
**(as verified by copy of DD-214 or copy of active duty military orders)**
- \_\_\_\_\_ 6. Both of my parents are deceased or I am or was (until age 18) a ward/dependent of the court  
**(as verified by legal documents showing student is/was a ward/dependent of the courts)**
- \_\_\_\_\_ 7. I am working on a master’s or doctoral degree during the term for which residency status is sought at a Florida institution  
**(as verified by official UWF academic record)**
- \_\_\_\_\_ 8. I am classified as an independent by the financial aid office at the institution  
**(as verified by written statement from UWF Financial Aid Office)**

A student who does not meet one of the qualifying items (1-8) in **Section B** may be classified as an independent student **only** if he or she submits documentation that he or she provides fifty (50) percent or more of the cost of attendance for independent, in-state students as defined by the financial aid office at UWF (exclusive of federal, state, and institutional aid or scholarships) and outlined on the reverse side of this form titled Undergraduate Final Budget”.

**Section C:**

**(check if applicable)**

\_\_\_\_\_ I can provide fifty (50) percent or more of the annual cost of attendance for independent, in-state students as defined by the financial aid office at UWF (exclusive of federal, state, and institutional aid or scholarships) and evidenced by supporting documentation (e.g. employment letters, tax returns, bank records, etc.) for the previous 12 month period.
